Valsad From June-16, and according to the same on examination-inspection-Visit-carried out by Inquiry Committee for the place of your proposed School of your Trust/Mandal and as per referred letter and according to the report the Certificate of Grant issued to Administrator of Vedant Multi Purpose School, Magod, Ta.Dist. Valsad for free education of children and Compulsory Education Right Rules 2009 of Gujarat and Compulsory Education Rights Rules 2012 with following conditions from June 2016 for Standard 1 to 5 (English Medium).

## : CONDITIONS :

 Given Grant could not Liable for extension, and it means no any grant given/ to joint the no standard above 8<sup>th</sup> standard and which not binding.



- 2. No any order or Government Resolutions, any instructions, are binding to School under provisions of Guides published by Indian Government or State Government under provisions of Rights to Free and Compulsory Education of Children for 2009 (Year 2009of 35) and Right to Free and Compulsory Education Rules 2012.
- 3. Admission given by the School to the poor class children of nearby area and interested group children, and including Primary Class in Standard 1<sup>st</sup>. admission given up to 25% children, and free and compulsory education provided till ending of education.
- Capitation Fee to be collect is prohibited, and therefore Trustee Mandal, or School not to collect capitation fee by any way or not collect other donations in exchange of fee or also not receive any articles.
- 5. For the purpose of given admission in school for children not follow any proceedings for children or their mother-father or guardian to taken any type of Scrining Test.
- 6. Due to not available evidence of age or due to religious caste, community or caste, place of birth out of such not to refuse to given admission to children for any above bases.
- 7. School should fixed that :-
  - (i) Any of the child whom given admission could not stop in any standard till the completion of primary education or also not rusticated from School.
  - (ii) No child should punish by way of physical or mental tourcher.
  - (iii) No child should order for the Board exam till the completion of primary education.
  - (iv) Every child should given certificate as per Rule 30 on completion of primary education.
  - (v) According to the provisions of rules whether the economical necessity student or student who are in need are given admission/included.

- (vi) (a) whether teachers are appointed who are having minimum education as per fixed by authority, are authorised by National Council of Teachers Education and under section23, Sub Section (1) of State Government.
  - (b) To see whether the education followed as fixed by Education Department vide Government Notification No. PRE-1110-223-K dt. 27th April, 2012.
  - (c) In the beginning of rules the educated teachers who are not having minimum educations they should obtain minimum education with time limit of 5 years from the beginning of rules.
  - (d) After published of Government Notification No. PRE-1110-223-K dt. 27th April, 2012 of Education Department any of the new teachers are appointed such teachers group passed the (TET) Teachers Eligibility Test fixed by the teachers is necessary.
  - (7) If the class room of the school are less in size of 300 Sq.ft. or as fixed in lists of rules for ratio of student-teacher (student Teacher Ratio) than as per rule 13 sub rule (1) of class (Gh)as ratio fixed (Ratio) which ever is less should be followed by the school according to same, And appointment of the teachers made as requirement mentioned in lists.
  - (8) Salary payable to the teachers and allowances should following the rules effected by the State Government and also conditions thereof.
  - (9) Teachers performed their as duties as mentioned in Section 24 of sub section (1) as per rules.
  - (10) Teachers or lady teachers do not join in private tuction activities.



- (11) Central Government or State Government or Administrators published guides and at the time of following orders such admission proceedings followed individually.
- (12) In reference of fees collected from the student followed strictly the Exchanges, Orders, Instructions or Guidelines published by Primary Education Administrators from time to time of by State Government.
- (8) School Provide education as per books prepared by authority.
- (9) Admission given to the student in School as per rule of section 19 fixed and according to the facilities provided in the school,
- (10) As mentioned in rule of section 1 the classes of school and maintain the standards and especially to provide the information, and followed the conditions to maintain the website of School and fill up the true and assured (DISE) District Information systems for educations under rule 13.
- (11) In the inside premises or outside of the school no any unauthorised classes to be run.
- (12) The buildings or constructions or Grounds of the School only be used for the purpose of education and skill development.
- (13) The school Mandali runs under registration Rules 1860 (21 st f year 1860) registered under Mandli or public Trust constituted under rules followed at the concern time.
- (14) School is not being runs for any person, group or Mandals of persons or for the profit of any persons.


